<p>The in-class theory portion of the program will be 314 hours in duration. The workplace practicum portion of 240 hours duration will follow immediately after completion of the theory portion of the program pending successful completion of all theory courses. The duration of this portion of the program will depend on scheduling at each individual student's work placement. The practicum placements cannot be guaranteed in any location and the students may have to travel for their practicum. Access to a vehicle will be required for practicum placements. Students must be available for days, evenings and night shifts. It is projected that most students will be completed by the end of February 2021, however some may need additional time to complete the practicum. A CPR, Safe Client Handling Injury Prevention Program (SCHIPP) and Non-Violent Crisis Intervention course will be held outside of the regular scheduled day. These workshops will be held in Winkler. Health Care Aide skill demonstrations will occur in Winkler during regularly scheduled class hours. Skill demonstration days will be indicated in your program schedule. Transportation to Red River College workshops and demonstrations will be your responsibility.</p>
